

**YOUTH PARTICIPANT WAIVER AND RELEASE OF LIABILITY:  
After-Hours Murder Mystery Event at the Library - November 27<sup>th</sup> from 6:00 pm to 8:00 pm**

**The Boyle County Public Library (hereafter known as the library)**

The youth participant, parent and/or guardian hereby freely, voluntarily and without duress executes this release under the following terms (hereafter "youth participant" shall mean "youth participant, parent and/or guardian"):

**1. Release and Waiver.** Youth participant does hereby release, forever discharge, and hold harmless the library and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature which arise or may hereafter arise from Youth participant's activities with the library. Youth participant understands that this release discharges the library from any liability or claim with respect to any bodily injury, personal injury, illness, death or property damage that may result from Youth participant's activities. Youth participant understands that the library does not assume any responsibility for or obligation to provide financial assistance or other assistance in the event of injury or illness.

**2. Medical Treatment.** Youth participant does hereby release and forever discharge the library from any claim whatsoever which arises or may hereafter arise because of any first aid, treatment, or service rendered or not rendered in connection with the Youth participant's activities with the library.

**3. Assumption of Risk.** The youth participant, parents and/or guardian, assume all risk for activities performed for the library, and understands that the normal activity of the Youth Program could include, but is not limited to:

- Investigation of fictional clues, police reports, autopsy reports, and other forms of evidence
- Travel through various rooms and levels of the library, including the use of stairs or elevator
- Interviewing of live actors portraying fictional murder suspects
- Library staff will be on hand to monitor the space in use
- Refreshments will be served

**4. Insurance.** The youth participant understands that, unless otherwise agreed to by the library in writing; the library does not carry or maintain health, medical or disability insurance coverage for any Youth participant. Each Youth participant is expected and encouraged to obtain their own medical or health insurance.

**5. Other.** Youth participant expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of Kentucky, and that this Release shall be governed by and interpreted in accordance with the laws of Kentucky. Youth participant agrees that in the event that any clause or provision of this release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this release that shall continue to be enforceable.

**6. Use of Image.** Photos of youth participants are often used in promotional materials or other reasons. The Youth participant agrees that the library shall be allowed to use youth participant images unless youth participant notifies the library at the event.
